We are a California-based construction and contracting company. We respect your privacy and are committed to protecting the personal information you provide to us in connection with inquiries, estimates, projects, and ongoing construction services. This Privacy Policy is provided in accordance with the California Consumer Privacy Act (CCPA), as amended by the California Privacy Rights Act (CPRA).

## **Information We Collect**

We collect personal information that is reasonably necessary to conduct our contracting business, including:
